

Consent to Receive Services

I, _____ (Parent/Guardian) of _____ (Child) consent to have my child receive services from the BGC Wetaskiwin voluntarily and without coercion or undue influence. I understand that consent may be withheld, given or revoked by the client or guardian at any time. This consent will remain in effect for the duration of the service (July 2 – August 23, 2024). I understand and agree to receive the services delivered as part of BGC Wetaskiwin. Programming activities such as recreational activities and outings involve certain elements of risk. Injuries may occur while participating in these activities. The following list includes, but is not limited to, examples of the types of injury, which may result from participating in the above-mentioned activities.

1. Traffic Accident on the van or bus while being transported to and from activities.
2. Tripping, falling, or injuring themselves while participating in programs.
3. Food allergy/choking while eating snack or meals.
4. A drowning while participating in a swimming activity.

The risk of sustaining these types of injuries result from the nature of the activity and can occur without fault of either the participant, or BGC Wetaskiwin, its employees/agents or the facility where the activity is taking place. By choosing to take part in the BGC Wetaskiwin programs, you are accepting risk that you /your child may be injured. The chance of an injury occurring can be reduced by carefully following instructions at all times while engaged in program activities.

Transportation

I am aware that my child may use various modes of transportation while accessing Off-Site Activities within the Summer Day Camp program at BGC Wetaskiwin and that staff to child ratios will be maintained during all off-site activities.

Walking Bus

1. Participants may walk to off-site locations to access parks and facilities in Wetaskiwin (within 2 kilometers).
 - a. Please ensure your child has proper footwear for walking.
2. The walking bus will not operate when there is extreme weather or temperatures. In these situations, the program will use the BGC Wetaskiwin bus.

BGC Wetaskiwin Bus

1. The BGC Wetaskiwin bus will transport participants to off-site locations in Wetaskiwin (see below for regular off-site locations) and field trips outside of Wetaskiwin to other locations in Alberta.
2. The bus will carry a maximum occupancy according to the number of seats.
